CSIR-Central Drug Research Institute, a laboratory of Council of Scientific and Industrial Research (CSIR) invites applications from Outside Experts/Retired Government Servants for engagement as Consultants in the area of GLP compliant animal experimentation facilities at CSIR-CDRI, Lucknow from Indian Nationals with the following job description and educational qualification:-

1. **Essential Qualification:** Ph. D. in Life Sciences/ Animal Sciences with more than 30 years of research experience in drug research and working with experimental animal models.
2. **Experience/ Desirable qualification :** Having administrative/ group leader experience of more than 05 years will be an added advantage.
3. **Job Requirements:** Candidates will have to advise for setting up of GLP complaint Animal facility at New Campus OF CDRI, better functioning of the existing facility and to advise on the monitoring of animal health, feed quality, breeding and maintenance of the experimental animals.
4. **Period of engagement of Consultant:** Consultant will be engaged on temporary basis initially for a period of six months, which may be extended depending on the requirements and on the basis of performance, by the Director CSIR-CDRI. The engagement will be coterminous with the project. Also and the engagement may be cancelled, at any time by CSIR-CDRI, without assigning any reason whatsoever by giving one month notice.
5. **Remuneration:** Selected candidate will be paid a consolidated amount up to Rs. 50,000 /- per month on the recommendation of the committee.
5. **Procedure for selection of Consultants:** The Consultant will be selected on the basis of performance in interview.
6. **Other facilities to Consultant:**
 1. Consultant will be provided space for office (sitting space).
 2. The Consultant shall have access to the CSIR-CDRI library, during the period of consultancy and will be allowed to borrow books as per the library rules.
7. **An agreement will be required to be signed by the Consultant.**
8. **The Consultancy will not entitle the concerned person to any claim of Government service and/ or CSIR service, in any manner**

9. General conditions for engaging Professional Consultant:

(1) The period of experience in the requisite discipline/area of work wherever prescribed, shall be counted with effect from the date of acquiring the prescribed minimum educational qualifications required for the post.

(2) Mere fulfillment of essential educational qualifications & experience does not entitle a candidate to be called for interview. The decision of CSIR-CDRI in all matters relating to eligibility, acceptance or rejection of applications, mode of selection and conduct of interview will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection from any candidate or his/ her agency.

(3) **Incomplete applications and applications not supported by attested copies of certificates of educational qualification, experience certificate, community certificate, testimonials, list of publications and reprints are liable to be summarily rejected.**
