SPECIFICATION FOR ULTRA LOW DEEP FREEZER (-80)

1. Should be of upright type.
2. Capacity of minimum 400 liters or above
3. Internationally reputed make and ISO certification
4. Durable stainless steel interior. Tough powder coated exterior constructed on steel gauge.
5. Freezer should have more than four insulated doors giving access to adjustable shelves.
6. Freezer should have heated air vent and air filter with heavy duty lockable castors and lockable outer doors and lids.
7. Freezer should have battery back-up and on board diagnostic software to report failures to service personnel.
8. Audible and visible alarms for temperature, power failure, system failure, battery low etc.
9. Freezer should use CFC-FREE, HCFC-FREE non flammable refrigerants. Compressor should be capable to run any voltage between 190 - 270V.
10. Freezer should have washable condenser filter indication
11. Freezer should be supplied with 3KVA servo voltage stabilizer.
12. Warranty for the equipment should be 3 years or more.
13. The freezer should be ½ filled by high quality SS storage racks for sample boxes
