सीएसआईआर-सीडीआरआई, लखनऊ द्वारा दिनांक 18 मई, 2025 को बाबू बनारसी दास यूनिवर्सिटी, बीबीडी सिटी, लखनऊ में कनिष्ठ सचिवालय सहायक (सामा./वि. एवं ले. /भं. एवं क्र.) के 07 पदों हेतु लिखित परीक्षा का आयोजन किया गया। लिखित परीक्षा की अनंतिम उत्तर-कुंजी दिनांक 19 मई, 2025 को सीडीआरआई वेबसाइट पर प्रकाशित की गयी तथा दिनांक 23 मई, 2025 तक आपत्तियां आमंत्रित की गयी थी। उत्तर-कुंजी के विरुद्ध प्राप्त आपत्ति का निपटान इस संस्थान के समसंख्यक वेबसूचना दिनांक 28 मई, 2025 द्वारा किया जा चुका है।

तदोपरान्त लिखित परीक्षा के मूल्यांकन के पश्चात मेरिट के आधार पर, संलग्न 228 अभ्यर्थियों को कम्प्यूटर टंकण गति तथा कम्प्यूटर के उपयोग में प्रवीणता परीक्षा हेतु चयनित किया गया है। कम्प्यूटर टंकण गति तथा कम्प्यूटर के उपयोग में प्रवीणता परीक्षा आवेदन प्रक्रिया के दौरान अभ्यर्थियों द्वारा चुने गये विकल्प/माध्यम के आधार पर अंग्रेजी या हिन्दी में आयोजित किया जायेगा।

The CSIR-Central Drug Research Institute (CDRI), Lucknow, conducted a written examination on 18th May, 2025, for the Jr. Secretariat Assistant (Gen./F&A/S&P) posts at the Babu Banarasi Das University, BBD City, Lucknow. The tentative Answer Keys of the written examination was published on the CDRI website on 19th May 2025 and objections were invited till 23rd May 2025. The objections received against the answer key have been disposed off vide this web notice of even number dated 28th May, 2025.

Accordingly, on the basis of merit list prepared after the evaluation of the competitive written examination, 228 candidates have been shortlisted for the proficiency test in Computer type speed and in using computer. The proficiency test in computer type speed and in using computer will be conducted in either English or Hindi, depending on the option selected by the candidates during the application process.
