Video Tracking System Specification:

- The software should be able to work with different types of mazes like, water maze, Elevated plus maze, T,Y,O-mazes, Radial Arm Maze and for other tests like, open field, place preference, object recognition for various parameters like latency to reach platform and time platform is crossed, performance time distance travelled, turning angles, turn angle velocity, speed, absolute direction of movement, movement pattern, score events, animal trajectory, distance, speed performance time in zone, movement pattern path length.
- System should be provided with Tele-switch- Video tracking which can handle remotely
 without any Human Interface so that subject can be placed under some particular
 environment and when no human interface is required in the lab.
- Should have an option to use frame-to-frame detection for precise monitoring of spontaneous activity and immobility
- Capable to analyse special animal behaviour like, rearing, grooming, relative movements, rotations, contacts, object exploration.
- Should have Detection Limit feature to actually track animals in almost every light conditions by adjusting threshold and Erosion.
- 3 Point Detection capability- Using Track nose point, Center of Mass and tail base of rodents.

Data Acquisition and Analysis:

- The software should be able to analyze data in real time as well as offline.
- It should be able to generate statically analyzed reports.
- It should provide facility for data output to Microsoft office tools to convert excel data log for single report as well as full setup of experiments.
- It should analyze centre of mass data log in time (sec), activity data log in distance (mm) and in event count, behaviour scoring, tracking line.
- It should provide zone transition list and event list reports with time evaluation and distribution of the occurrences.
- Standard calculations related to tracking line, time entries in zones, average speed.
- Should be provided with branded and latest edition of PC work station with minimum 8GB RAM, and 2TB data storage capacity.
