
Agencies willing to participate in e-tender process must be registered under Registrar of Company/should be registered firm and fulfill Local/Central Government statutory compliances under Contract Labour (Regulation & Abolition) Act 1970 and registered for ESI, EPF, GST and Labor Department of Government of India/Govt. of Uttar Pradesh having successfully completed one similar work costing not less than 80% of estimated cost i.e. Rs. 3,01,82,029/-(Three Crore One Lakh Eighty Two Thousand Twenty Nine Only) or above or two similar works costing not less than 50% i.e. Rs. 1,88,63,768/-(One Crore Eighty Eight Lakh Sixty Three Thousand Seven Hundred Sixty Eight Only) or above or three similar work costing not less than 40% i.e. Rs. 1,50,91,014/-(One Crore Fifty Lakh Ninety One Thousand Fourteen Only) or above in the last any three years. Agencies must have relevant work experience in the National Research laboratories, hospitals, institutes and research centers/similar organizations of Central/State Govt./Autonomous Bodies/Public Sector Undertakings.



- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c.
