- 6. Co-ordination with other agencies operating at site i.e. electrical, civil, statutory authorities etc. for carrying out the work including arrangement for shut-downs/ inspection by fire authorities.
- 7. The Contractor shall keep the tools/instruments at site for Operations and also arrange to bring to site any other Tools & parts etc. as per requirement. Inventory of items listed in tender must be maintained by contractor.
- 8. Agency/contractor will carry out preventive service, oiling, greasing, phase changeovers, change of glands, water charging in batteries etc. at no additional cost to CSIR-CDRI. Further, bring in notice of requirement of change in spares.

[B] Scope of work in Fire alarm & Public Announcement system:

- 1. Agency will immediately attend the response generated by optical detectors, Repeater panels, MCP, hooters, complete with Fire Alarm Panel and speaker systems and immediately coordinate with security personals to attend the affected site.
- 2. Reporting of failures, faults in optical sensor, false alarm, PA system, MCP glass break etc. and restore the operation within the shortest possible time
- 3. Operation shall be done in accordance with the operational guidelines along with relevant BIS standards & statuary guidelines. Agency shall also make demonstration/mock drill to CDRI staff (once in every month) the use of fire alarms, response and guide them for regarding safely evacuation of premises in case of emergency.
- 4. Agency shall coordinate /cooperate with the security personals &fire fighting team and other agencies operating at site i.e. electrical, civil, statutory authorities etc. and

the assist them in safely evacuation of personals from building & will extinguish the fire in emergency situations.

- 5. Maintaining daily logbook of events, complaint registers and make them available as per requirement.
- 6. The contractor should provide medically fit contractual workers and should follow the instructions for the prevention of Covid-19 & other order issued by Director, CDRI, and Govt. of India.
- 7. The contractor shall instruct all contractual workers to wear clean MASK and Hand Gloves on the duty and use of sanitizers during duty.
- 8. The contractual worker should down load "Arogya Setu App in their personnel Mobile & status must be safe.

Trained Job Personal:

The agency shall be responsible to carry out the work as per defined scope and to maintain specific jobs with following experience/skilled manpower:

- 1. **Supervisor (01 no's) [Skilled]:** Must be graduate/ diploma in any stream of engineering and have detailed knowledge of optical sensor, fire sensors, fire fighting equipment and devices and computer controlled fire alarm and PA system. The supervisor will work in general shift and responsible for fire fighting, System management in CDRI.
- 2. Fire Technician (02 no's) [Semi-skilled]: Must have adequate knowledge of operation of fire pump, jockey pump and DG pump based operation, fire fighting equipment, pumps or any other devices. The personals must be aware of operation and use of fire extinguisher. The personals shall be responsible to handle any emergency situation and execution of fire fighting operation as per statuary norms.
- 3. **Technician (Electrical) (01 no's)[Semi-skilled]:** Must have adequate knowledge and experience of fire electric panels, fire alarm and PA system. The person shall be responsible to make the electric supply arrangement in the fire related electric panel and pumps. Line phase change, starter panel, change in oiling, greasing, ball bearing, water/solvent in battery, replacement of gland in motor/ pump shall be job responsibility of concerned personal.
- 4. **Technician (Networking/communication) (01 no's)[Semi-skilled]:** Must have knowledge of fire panels looping, networking, Manual call points, hooters and responsible for trouble free operation. The person will attend the job at site immediate and rectify the error in such devices.
- 5. **Fire Operator (06 no's)[Semi-skilled]:** Must have relevant experience and knowledge of water based fire fighting system, operation of fire extinguishers, operation of fire alarm and PA system, pump operation.

- 6. The agency must ensure arrangement of manpower in shift in such a way that 3 Fire Personal+1 supervisor/trained technician available from 6AM to 10PM (1st and 2nd shift) and 3rd shift must have minimum to 3 manpower's. Fire Operator should have 03-years' experience in Fire Fighting & Fire Alarm system and supervisor must have 03years experience in the same field.
- 7. Every employee so engaged by the contractor shall wear appropriate uniform and personal protection equipment of standard quality and a badge wearing his/her name, while on duty. The said uniform and badge shall be provided by the contractor at his own cost & they should have to work as fire fighter , in case of emergency.

The contractor shall engage the manpower whose age shall be above 18years and physically sound to perform the assigned activity and must not be indulged in tobacco, gutkha, smoking or alcohol consumption during the office Hours. In end of every month, the performance will be assessed and CSIR-CDRI has right to replace the personal if assessed performance not found up to the mark.
- 9. Contractor has to make deployment of manpower at strategic locations and Contract personal who had made entry to open for duty shall not be found absent from his duty place during the office time, Non-compliance of such instruction will be considered as absence and penalty of double the full day salary of manpower absent.
- 10. The contractor shall disburse the wages to its staff deployed forgiven job in every month through ECS/NEFT/RTGS or by Cheque only and submit proof of disbursement of wages; EPF, ESIC and GST deposit details.
- 11. Contract agency requires maintaining inventory of items listed in **Annexure-3** of price bid along with the quoted price of each item. Replacement of spare will be made as per requirement and payment on actual basis will be made.

Terms and Conditions of IEM in CSIR and constituent Labs/Instts.

1. The engagement will be as independent External Monitor (IEM) on contract basis in Council of Scientific and Industrial Research and its constituent Labs./Instts. Spread across India.

2. The Major role of the IEM would be implementation of integrity pact in CSIR for entering into contracts for procurement of material and service contracts with a threshold value of 3 Crore and above (under revision) to prevent/reduce/culminate corruption, bribes or any other unethical practices.

3. The IEM is to Monitor and review the tendering process from inception to the culmination of the contract and compliance to the Integrity pact therein.

4. The IEM would be required to review independently and objectively, whether and to what extent the parties (CSIR or its Lab/Contractor) comply with the obligations under the Integrity pact therein.

5. The IEM wil not be subject to instructions by the representatives of the parties and will perform their functions neutrally and independently.

6. The Independent External Monitor will not have administrative or enforcement responsibilities. He will co-ordinate his efforts with the help of the Chief Vigilance Officer, CSIR and other anti-corruption institutions such as the Central Vigilance Commission, New Delhi. He may engage services of outside agencies such as accounting firms, law firms etc. with prior approval of Joint Secretary (Administration), CSIR for CSIR Hq. and Director for CSIR Labs. If required, in discharge of his responsibilities.

7. A contentious issue may be referred to the nominated IEM of the contract either by CSIR or its Lab or by a bidder/contractor or by CVO. If referred to by a party other than CSIR, then IEM will duly inform CSIR (Joint Secretary, Administration)/ Director of CSIR Lab prior to commencement of his/her investigation.

8. The independent External Monitor will have access to all officers and all records of CSIR or its Laboratories relating to the matter connected with or incidental to the tender or contract of having a bearing with that. He/ She will also have access to bidder's records and information regarding its dealing with CSIR.

9. IEM may hold meetings with the bidder or contract processing officers or Joint meetings with both to resolve complaints.

10. If the Independent External Monitor observes or suspects an irregularity, he/she will inform Head of the Division. Once the Independent External Monitor is satisfied that an irregularity has taken place, he/she may inform Joint Secretary (Administration) at CSIR Head Quarter or Director of CSIR Lab.
